Community Development

Trustee DeYoung shared that we had 49 building permits last month, with a valuation of \$3,000,000,. Included in the permits were U.P.S.- \$500,000 for Addition to existing Structure; Calumet Industry-\$500,000 for Solar Panels; \$1,000,000 for new structure.

Parks and Recreation

Trustee Perkins shared that registration is now available for our **Summer Day Camp and Sports Academy programs**. Sign up early and take advantage of our monthly payment plan options. Spaces are limited. Registration is available at the Community Center or online at southholland.org.

Community Life

The South Holland Chorale is participating in the **Midwest Underground Railroad Network Celebration** of Black History Month, Friday February 21st from 6pm – 8pm, at First Reform Church. Members of the Midwest Underground Railroad Network will share the history of the underground railroad through music, drama and storytelling. This is a free event.

Several talented South Holland artists will have their art on display at our annual **Artists' Gallery**, which takes place March 6-7 at the Community Center. The Gallery is free and open to the public, so stop by and view their works of art. Visit southholland.org for information.

Public Safety

Trustee Johnson shared that the Police Department will be hosting "Pancakes with the Police" on March 14 from 9:30 a.m., to 11:30 a.m. at the Heritage House. There is room for up to 50 residents. This is an opportunity for residents to meet and enjoy quality time with South Holland police officers. Discussions regarding public safety and community events will be shared with all in attendance. Public Works

Trustee Reed shared that we completed our partnership with Verde Solutions to install solar panels on five municipal buildings, advancing our commitment to sustainability and renewable energy. The results speak for themselves. Approximately 2,000 solar panels were installed. These solar panels will help prevent 25,000 metric tons of C02 emissions, which is equal to 2.5 million gallons of gasoline avoided, or 8,500 tons of waste recycled instead of landfilled.

The Lead Service Line Replacement project is progressing well. To date, we have replaced 150 lead service lines and expect to complete another 100 by the end of the project in May. This phase is funded by an IEPA Forgivable Loan of \$2.8 million, which allows us to remove 250 lead service lines.

There being no additional business to come before the President and Board of Trustees, Trustee Reed moved that this meeting adjourn. Trustee Johnson seconded the motion. Ayes all on the roll. Meeting adjourned. Next regular meeting of the President and the Board of Trustees will be held on Tuesday, March 11, 2025, at 8:00 PM, in the Council Room of the Municipal Building, County of Cook, South Holland, Illinois.
