Community Development

Trustee DeYoung shared that we had 103 building permits last month, with a valuation of more than \$14,000,000. Included in this month's permits was a multi-million-dollar project for the Family Athlete Center, \$800,000 for an HVAC system for Miniat and several permits for Roofing and Blacktop.

Parks and Recreation

No report was given in Trustee Perkins' absence.

Community Life

Trustee Nylen shared that the next **Mayor's Coffee** is Tuesday, December 2, 7pm, at the Community Center. Residents are invited to hear from and speak with Mayor De Graff. Coffee and refreshments are provided.

Our annual **Winter Wonderland** is coming up on Friday, December 6 from 6-8pm at Veterans Park. The event begins with a tree and park lighting, followed by visits with Santa, an iceless skating rink, trolley rides, train rides on the South Holland Express, and more. Visits with Santa are for South Holland residents and must be registered in advance at the Community Center.

Finance

Trustee Russell moved for **Approval of payments of vouchers as listed on Register #223 for a total of \$1,356,219.48** covering day-to-day operations, vendor payments and payroll. Trustee Johnson seconded the motion.

Public Safety

Trustee Johnson shared that as we enter the busy holiday season, the Police Department would like to remind residents to take precautions to help prevent package theft in our neighborhoods. Increased online shopping brings more deliveries, and unfortunately, more opportunities for theft. To help protect your deliveries, please consider the following safety tips: Schedule deliveries for times when you or a family member will be home; Request "signature only" deliveries when available, so packages are not left unattended; Coordinate with a trusted neighbor who can receive your package if you're not home; Have packages delivered to your workplace or another secure location, if possible; Install security cameras or video doorbells, which can deter thieves and help identify potential offenders; Place a hold on your deliveries if you'll be away for the holidays to prevent packages from being left unattended; Consider using secure pickup locations or package lockers offered by delivery services.

As always, if you observe suspicious behavior or suspicious vehicles, please contact the Police Department. By working together—residents, businesses, and law enforcement—we can make this a safe and secure 2025 holiday season here in South Holland.

Public Works

Trustee Reed shared that Cook County is set to remove and replace the bridge over Thorn Creek on 170th St. Between now and April, they will trim trees, remove medians, and establish temporary travel lanes. Actual construction is scheduled to get underway in April. One travel lane in each direction will remain open but anticipate temporary closures and restrictions.

Branch and Specials collection has wrapped up for the winter season. The public bathrooms at Veterans Memorial Park, Maicach Park, Paarlberg Park, and Gouwen's Park have been winterized. All park lights have been adjusted for daylight savings time.

Public Works is preparing our plow fleet for winter, including the Calcium Chloride Anti-Icing Spray system. This will be our fourth year utilizing the system to pretreat our critical roads, intersections, and bridges with Calcium Chloride before each storm. This year, we have added three new spray attachments to our flatbed trucks for better distribution across the village.

There being no additional business to come before the President and Board of Trustees, Trustee Johnson moved that this meeting adjourn. Trustee Reed seconded the motion. Ayes all on the roll. Meeting adjourned.
